Terms of Service

Terms of Service Brighter Horizons Center Effective Date: January 5, 2025

1. Scope of Services

Brighter Horizons Center provides counseling, mentoring, educational support, and related social services for adolescents and families. Services are provided in-person, by phone, or virtually, depending on the program.

2. Eligibility

Services are generally intended for teens and families experiencing behavioral, emotional, or social challenges. Intake assessments may be required to determine eligibility.

3. Code of Conduct

All clients and guardians must treat staff and other participants with respect. Threats, violence, harassment, or disruption of services may result in discharge from the program.

4. Consent and Confidentiality

Clients and guardians will receive and must sign a separate Client Consent Form and Counseling Disclosure Statement outlining rights, confidentiality, and limits to confidentiality under Texas law.

5. Termination of Services

Brighter Horizons Center reserves the right to terminate services if:

- The client is not actively participating
- Safety concerns arise
- Terms or rules of the program are violated

6. Minors

Consent from a parent or legal guardian is required for clients under the age of 18, unless otherwise permitted by Texas law.

7. Changes to Terms

We reserve the right to modify these Terms of Service at any time. Continued use of services implies acceptance of any changes.

- -A court orders the release of information
- -Written consent is provided

call 911 or go to the nearest hospital.
